RONIN MARKET TERMS OF USE

These Ronin Market Terms of Use, together with any supplemental terms and policies incorporated herein, constitute a legally binding agreement (collectively, the "Terms," "Terms of Use" or "Agreement") made between you, whether personally or on behalf of an entity ("you") and Sky Mavis Pte. Ltd. ("Sky Mavis", "we", "us", or "our") concerning your access to and use of the https://marketplace.roninchain.com/ website (the "Site") and one or more Ronin Market applications (the "App"), as well as any other media form, media channel, mobile website or mobile application made available by or on behalf of Sky Mavis and related, linked, or otherwise connected thereto (collectively, with the Site and the App and any Smart Contracts or other software or services enabled thereby, the "Services"). The Services include any distributed application running on one or more blockchain networks, which may include the Ethereum Network and Ronin Network (the "Blockchains"), using smart contracts (each, a "Smart Contract") that interact with or enable the use of a user's Digital Collectibles (as defined below), including non-fungible tokens ("NFTs"), and other digital assets. These Digital Collectibles can be visualized via the Services and other Third-Party Services.

The Services are not intended for distribution to any person or entity in any jurisdiction or country where such distribution or use would be contrary to law or regulation, or which would subject us to any registration requirement or other regulation within such jurisdiction or country. Accordingly, you are solely responsible for your compliance with all applicable laws when you access and/or use the Services.

The Services are intended for users who are at least 18 years old. People under the age of 18 are not permitted to use or register for the Services.

THE SERVICES INCLUDE THE RONIN MARKET, A FRONT-END PLATFORM THAT ALLOWS USERS TO OFFER TO SELL AND SELL DIGITAL COLLECTIBLES TO, AND OFFER TO BUY AND BUY DIGITAL COLLECTIBLES FROM, OTHER USERS. 1. THE SERVICES

1.1 <u>General</u>. Users of the Services, including any potential Digital Collectible creators, may be able to mint certain Digital Collectibles on the Blockchains. In order to access certain Services, including to purchase any Digital Collectibles, a user must connect a compatible digital wallet to the Services. Sky Mavis makes no guarantees regarding the validity, capability, quality, or legality of any Smart Contracts or Blockchain protocols.

- 1.2 <u>Minting Digital Collectibles</u>. By minting a Digital Collectible, you agree to comply with any terms, including licenses or payment rights that are embedded within or otherwise included with any such Digital Collectible. Sky Mavis does not guarantee any Digital Collectibles or collections thereof will be transferable to or have any utility in connection with any other platform.
- 1.3 <u>Digital Collectible Terms</u>. There may be limits on or to other terms applicable to the purchase, sale or use of Digital Collectibles, or Digital Collectible collections, comprising Sky Mavis' Content (defined below), including, without limitation, any fee payable in connection with any subsequent sale of a Digital Collectible or a collection, regardless of whether such sale takes place on or through the Service (each such subsequent sale, a "Secondary Sale," and such fee, a "Secondary Sale Fee"), and Sky Mavis will display such terms at point of sale or otherwise within the Services (the limits and other terms, collectively, the "Digital Collectible Terms").
- <u>Digital Collectible Transactions</u>. All transactions regarding Digital Collectibles are managed and confirmed on the Blockchain(s). You understand that your Blockchain public address may be made publicly visible whenever you engage in a transaction. Sky Mavis is not and shall not be a party to any transaction or dispute between any initial minter of a Digital Collectible (other than any Digital Collectible that we specifically mint) and any subsequent owner of such Digital Collectible (unless we are the owner of such Digital Collectible), whether arising from any rights granted in that Digital Collectible or otherwise, unless otherwise set forth in connection with such Digital Collectible.
- 1.5 Ronin Market. Certain Digital Collectibles can be bought, sold, and traded with other users on the Ronin Market ("Ronin Market"). Pricing and payment terms on the Ronin Market, including specific details relating to the offering of any Digital Collectibles, will be set forth at the point of sale. Sky Mavis may, in its sole discretion, limit the use of the Ronin Market to the listing and sale of certain Digital Collectibles or collections of Digital Collectibles. Digital Collectibles and Digital Collectible collections listed on the Ronin Market are being offered by the individuals seeking to sell such Digital Collectibles or collections ("Sellers"), and the actual contracts for sale are between the Sellers and the individuals seeking to buy such Digital Collectibles or collections ("Buyers"). A user who has purchased a Digital Collectible on the Ronin Market, whether in its initial sale or via Secondary Sale, may be able to resell that Digital Collectible on the Ronin Market and/or on a third-party marketplace, subject to these Terms of Use and any supplemental terms and conditions. Except where explicitly set forth at point of sale, Sky Mavis is not the Seller of any Digital Collectible listed on the Ronin Market and will not provide or deliver any Digital Collectibles. While we may, in our discretion, help facilitate resolution of Claims or other disputes through various programs, and unless otherwise stated in our Services, we have no control over the ability of Sellers to sell or receive compensation for Digital Collectibles, the ability of Buyers to purchase or pay for Digital Collectibles, or that a Buyer and Seller will actually complete a transaction on the Ronin

Market. While Sky Mavis may provide pricing and guidance for Digital Collectibles sold by Sellers on our Ronin Market, such information is solely informational. We do not have control over the quality, safety, timing, legality, failure to provide, or any aspect whatsoever of any Digital Collectibles or collections of Digital Collectibles advertised or sold by Sellers, or of the integrity, responsibility, or any actions of any users. Sky Mavis makes no representations about any transactions or interactions, whether public, private, online or offline, including about the suitability, reliability, timeliness or accuracy thereof.

- 1.6 <u>Selling on the Ronin Market</u>. PLEASE CAREFULLY READ THIS IMPORTANT INFORMATION ABOUT PROCEDURES FOR SELLING ON THE RONIN MARKET BEFORE USING THE RONIN MARKET. To help prevent the funding of terrorism and money laundering activities, Sky Mavis may ask you to provide additional information or copies of identifying documents that will allow us and/or our Third Party Payment Service Providers (defined below) to identify you. We reserve the right to require you to provide such additional information and documents. Failure to provide such information upon request, as well as any other violation of these Terms of Use, may result in your removal from the Services and/or the termination of your ability to sell, purchase or use Digital Collectibles via the Ronin Market.
- 1.7. <u>DISCLAIMERS WITH RESPECT TO THE SERVICES</u>. ANY INFORMATION PROVIDED BY OR ON BEHALF OF SKY MAVIS ON ANY PLATFORM OR THROUGH THE SERVICES IS FOR INFORMATIONAL AND ENTERTAINMENT PURPOSES ONLY AND SHOULD NOT BE CONSTRUED AS, NOR IS IT INTENDED AS, AN OFFER TO SELL, OR THE SOLICITATION OF AN OFFER TO BUY, ANY INTEREST IN ANY SECURITY, ENTITY, INVESTMENT VEHICLE OR CONTRACT, INCLUDING, BUT NOT LIMITED TO, WITH RESPECT TO DIGITAL COLLECTIBLES. SKY MAVIS DOES NOT FACILITATE, EFFECTUATE, OR CONTROL ANY TRANSACTIONS INITIATED THROUGH THE SERVICES, AND SKY MAVIS WILL NOT BE LIABLE FOR ANY RESULT OF ANY TRANSACTIONS, INCLUDING BUT NOT LIMITED TO, ANY FAILED, FRAUDULENT, OR INADVERTENT TRANSACTIONS THAT MAY RESULT IN ANY LOSSES TO YOU. - (a) Sky Mavis is not responsible for the operation of the blockchain-based software and protocols underlying the Blockchains;
- (b) Sky Mavis does not have possession, custody, or control over any Digital Assets, Digital Collectibles, or other applications or protocols on the Blockchains (other than any Digital Assets or Digital Collectibles we may hold for ourselves or any applications or protocols we created and continue to maintain control over to the extent possible depending on how the application and/or protocol is deployed on the respective Blockchain);
- (c) Sky Mavis does not have possession, custody, or control over any of your funds, including any Digital Assets or Digital Collectibles, at any time because when you interact with the Blockchains, you retain complete control over your funds and Digital Assets and Digital Collectibles at all times;

- (d) Sky Mavis cannot and does not at any time guarantee the functionality, security, or availability of the Services, which are contingent on the functionality, security, or availability of the Blockchains, which are independent and beyond the control of Sky Mavis;
- (e) The Services rely on technology that may be subject to sudden changes or developments, and Sky Mavis cannot guarantee that your access to the Services will be uninterrupted or error-free, that your Digital Assets or Digital Collectibles will be secure at all times, or that your transactions will be successful;
- (f) There may be non-refundable gas fees associated with any transactions on the Blockchains that you shall be solely responsible for;
- (g) Sky Mavis has no control over any developers, applications, Digital Assets, or Smart Contract(s) that may be active or deployed on the Blockchains, and you are solely responsible for any Losses that are related to or arising from your use and/or access thereof;

You hereby accept and assume all risks related to, arising from, or associated with using, or accessing any application(s), Digital Assets, Digital Collectibles, or Smart Contract(s), interacting with any applications, Digital Assets, Digital Collectibles, or Smart Contracts on the Blockchains, and/or otherwise engaging in any transactions or developments on the Blockchains, whether stated by us in these Terms or otherwise. Furthermore, you understand and agree that Sky Mavis has no liability or responsibility whatsoever for the activities of any developers conducted on the Blockchains or otherwise accessible via the Services.

1.8. <u>Updates, Modifications and New Services</u>. You understand that the Services may be constantly evolving. As a result, we may require you to accept updates to continue to use any portion of the Services. You acknowledge and agree that we may update the Services with or without notifying you. You may need to update third-party software from time to time in order to use the Services. Any future release, update or other addition to the Services shall be subject to these Terms of Use. Sky Mavis, its suppliers and service providers reserve all rights not granted in these Terms of Use. Any unauthorized use of any Services terminates the licenses granted by us pursuant to these Terms of Use.

Furthermore, we may need to provide additional terms for specific services (and such services are hereby deemed as part of the "Services" hereunder and shall also be subject to these Terms). These additional terms and conditions, which are available with the respective service, then become part of your agreement and understanding with us if you use those services. In the event of a conflict between these Terms and any additional applicable terms we may provide for a specific service, such additional terms shall control for that specific service.

We reserve the right in our sole discretion to modify, suspend, or discontinue, whether temporarily or permanently, any Service (or any features or parts thereof) at any time and without liability.

2. USER REGISTRATION

2.1. <u>Creating an Account</u>. In order to access certain features of the Services, you may be required to create an account on the Services ("Account"). Your Blockchain address functions as your identity on the Ronin Market. Thus, you will need a compatible Blockchain address and digital wallet to access the Service. Your account on the Services will be associated with your blockchain address; however, you may be able to add additional information to your Ronin Market persona, such as a nickname, to your Account.

Your Account will be associated with your linked blockchain address and display the Digital Collectibles for that blockchain address (and if applicable, any content associated with such Digital Collectibles). By using your wallet in connection with the Service, you agree that you are using that digital wallet under the terms and conditions of the applicable wallet provider. You understand that wallets are not operated by, maintained by, or affiliated with Sky Mavis, and we do not have custody or control over the contents of your wallet and have no ability to retrieve or transfer its contents. Sky Mavis accepts no responsibility in connection with your use of any wallet, and we make no representations or warranties regarding how the Service will operate with any specific wallet.

- 2.2. <u>Registration Data</u>. In creating an Account and as applicable, you agree to: (i) provide true, accurate, current, and complete information about yourself as prompted by the registration form, including contact information such as your email (the "Registration Data"); (ii) maintain and promptly update the Registration Data to keep it true, accurate, current, and complete; (iii) consent to us using your Registration Data in any manner permitted under applicable law, including sharing it with third parties; and (iv) consent to receive electronic communications from us (e.g., via email or other means) regarding notices about your account and other promotional and marketing communications from us or third parties with whom we have shared your contact information. You represent that you are (A) at least eighteen (18) years old; and (B) not a person barred from using the Services under the laws of your place of residence or any other applicable jurisdiction.
- 2.3. <u>User Responsibilities.</u> You are responsible for all activities that occur under your Account. You are responsible for any use of any payment instrument (e.g., your digital wallet and/or debit or credit card information, as applicable) initiated or enabled by or through your Account. You may not share your Account or password with anyone, and you agree to notify us immediately of any unauthorized use of your password or any

other breach of security. If you provide any information (including without limitation Registration Data) that is untrue, inaccurate, not current, or incomplete, or we have reasonable grounds to suspect that any information you provide is untrue, inaccurate, not current, or incomplete, we have the right to suspend or terminate your Account and refuse any and all current or future use of the Services (or any portion thereof). You agree not to create an Account using a false identity or information, or on behalf of someone other than yourself, except to the extent expressly permitted by us in writing. We reserve the right to remove or reclaim any usernames at any time and for any reason, including but not limited to, claims by a third party that a username violates the third party's rights. Notwithstanding anything to the contrary herein, you acknowledge and agree that you shall have no ownership or other property interest in your Account, and you further acknowledge and agree that all rights in and to your Account are and shall forever be owned by and inure to our benefit.

- 2.4. <u>User Representation and Warranties</u>. When you use the Services, you hereby represent and warrant, to and for our benefit, our affiliates, and their respective representatives, as follows:
- (a) Authority. You have all requisite capacity, power, and authority to enter into and perform your obligations under these Terms.
- (b) Accuracy of Information. All information provided by you to Sky Mavis and/or its third-party designees, including Registration Data, is accurate and complete. None of: (i) you; (ii) any of your affiliates; (iii) any other person having a beneficial interest in you; or (iv) any person for whom you are acting as agent or nominee in connection with these Terms is: (A) a country, territory, entity or individual included in any trade embargoes or economic sanctions list (such as the United Nations Security Council sanctions list or the Office of Foreign Assets Control of the U.S. Department of the Treasury list as provided at http://www.treas.gov/ofac), or a person or entity prohibited under the OFAC programs, regardless of whether or not they appear on the OFAC list, or a person or entity included in the denied persons or entity list of the U.S. Department of Commerce; or (B) a senior foreign political figure, or any immediate family member or close associate of a senior foreign political figure.
- (c) Independent Investigation and Non-Reliance. You are sophisticated, experienced and knowledgeable regarding blockchain technologies and digital assets, including Digital Collectibles. Additionally, you have conducted a comprehensive and independent investigation of the Services and the matters contemplated by these Terms, have formed your own independent judgment regarding the benefits and risks of and necessary and desirable practices regarding the foregoing, and, in making the determination to use the Services, you have relied solely on the results of such investigation and such independent judgment. Without limiting the generality of the foregoing, you understand, acknowledge and agree that the legal requirements pertaining to blockchain technologies and digital assets generally, including Digital Collectibles and NFTs, are uncertain, and you have conducted an independent investigation of such potentially applicable legal requirements and the resulting risks

and uncertainties, including the risk that one or more governmental entities or other persons may assert that any digital assets or cryptographic tokens (including Digital Collectibles) may constitute securities under applicable legal requirements. You hereby irrevocably disclaim and disavow reliance upon any statements or representations made by or on behalf of, or information made available by us in determining to enter into these Terms of Use or use the Services.

- (d) *Litigation*. There is no legal proceeding pending that relates to your activities relating to the Services or other token- or digital asset- trading or blockchain technology-related activities.
- (e) Compliance. You have not failed to comply with, and have not violated, any applicable legal requirement relating to any blockchain technologies or token trading activities. No investigation or review by any governmental entity is pending or, to your knowledge, has been threatened against or with respect to you, nor does any government order or action prohibit you or any of your representatives from engaging in or continuing any conduct, activity, or practice.
- (f) Legality of Use. Any and all of your activities (whether conducted in your personal capacity or on behalf of a third party), including but not limited to any use or access to the Ronin Network or any related blockchain protocols, Smart Contracts, Digital Assets, or any Service related to or arising therefrom, are lawful under the laws of all applicable jurisdictions in which such activities may be conducted or made accessible to. You are solely responsible for your use of the Service.

You must provide all equipment and software necessary to connect to the Services, including but not limited to, a mobile device that is suitable to connect with and use the Services, in cases where the Services offer a mobile component. You are solely responsible for any fees, including Internet connection or mobile fees, that you incur when accessing and/or using the Services.

3. COMMUNICATIONS

3.1. <u>General</u>. By accessing or using the Services, including the creation of an Account, you consent to receive communications from us by electronic means (e.g., via email, Discord, or by posting notices to the Services). These communications may include notices about your use of the Service (e.g., transactional information) and are part of your relationship with us. You agree that any notices, agreements, disclosures or other communications that we publish electronically will satisfy any legal communication requirements, including, but not limited to, that such communications be in writing. You should maintain copies of electronic communications from us by printing a paper copy or saving an electronic copy. We have no obligation to store for your later use or access any such electronic communications.

4. FEES AND PAYMENT

- 4.1. <u>General</u>. All pricing and payment terms for Digital Collectibles are as indicated at point of sale or otherwise on the Services, and any payment obligations you incur are binding at the time of purchase. You may not substitute any other currency, whether cryptocurrency or fiat currency, for the currency in which you have contracted to pay at the time of purchase. For clarity, no fluctuation in the value of any currency, whether cryptocurrency or otherwise, shall impact or excuse your obligations with respect to any transaction. Whether a particular cryptocurrency is accepted as a payment method by us is subject to change at any time in our sole discretion.
- 4.2. <u>Digital Collectible Terms</u>. When you purchase a Digital Collectible, you agree that you have read, understand, and agree to be bound by any Digital Collectible Terms applicable to the sale of that Digital Collectible, including any Secondary Sale Fee (regardless of whether such Secondary Sale Fee is enforced or supported by the platform, blockchain or marketplace that facilitates a Secondary Sale). If applicable, you further agree that you will bind any subsequent purchaser of the Digital Collectible to such Digital Collectible Terms.
- 4.3. Payment Processing and Related Services. Payment processing and related services (e.g., digital wallet management, card payment and/or acceptance, merchant settlement) for the Services may be facilitated through third-party application providers that may or may not be decentralized, such as but not limited to Transak, Metamask and Ronin Wallet (each, a "Third Party Payment Service Provider"). Your use of the Services and any payment processing and related services provided by a Third Party Payment Service Provider is subject to your agreement(s) with such Third Party Payment Service Provider for such Services and payment processing and related services, as may be modified by the Third Party Payment Service Provider from time to time (collectively, "Third Party Payment Service Provider Agreement(s)"). For clarity, Sky Mavis is not a party to such Third Party Payment Service Provider Agreement and has no control or liability whatsoever regarding any Third Party Payment Service Provider. As a condition of using the Third Party Payment Service Provider's payment processing and related services, you must provide accurate and complete information, and you authorize us to share this information with the Third Party Payment Service Provider and to charge your payment method for all amounts that may become due under this Agreement, as applicable. Your use of the Third Party Payment Service Provider's payment processing and related services is conditioned upon your compliance with the Third Party Payment Service Provider Agreement, and if the Third Party Payment Service Provider Agreement is terminated by the Third Party Payment Service Provider, you may not be able to use the Services, or you may have your use of the Services suspended or terminated. We may change or add other payment processing services at any time upon notice to you, which may be subject to additional terms or conditions. We will have no control over the Third Party Payment Service Provider's payment processing and related services and cannot reverse or refund any transactions. We and any Third Party Payment Service Providers reserve the right to limit or otherwise restrict the amount and/or volume, the type of selected payment method (whether with cryptocurrency or otherwise), and the

frequency as well as take any and all other steps for our own risk management and business purposes, which shall be determined at our own discretion.

- 4.4. <u>Gas Fees</u>. Each Blockchain may require the payment of a transaction fee (a "Gas Fee") for every transaction that occurs on such Blockchain, with such Gas Fee to be based on the structure and composition of the respective Blockchain. This means that you may need to pay a Gas Fee for each transaction that occurs via the Services. Gas Fees may vary based on market conditions on the applicable Blockchain, and Sky Mavis shall have no liability to you in connection with the same.
- 4.5. Other Fees. For our Services, we may receive certain fees. We do not set, collect, or determine any other applicable costs, fees, and expenses associated with buying and selling a Digital Collectible, including but not limited to any gas or transaction fees. These costs, fees, and expenses are paid directly to the seller payment processor, blockchain validator, or other respective third party as applicable and further described in this Section 4. - 4.6. <u>Taxes</u>. It is your responsibility to check this Agreement periodically for changes. 9. YOUR RESPONSIBILITIES

- 9.1. <u>Your Data, Information, and Accounts</u>. - (c) for entities, you have ceased to operate in the ordinary course, made an assignment for the benefit of creditors or similar disposition of your assets, or become the subject of any bankruptcy, reorganization, liquidation, dissolution or similar proceeding.

You acknowledge that we are under no obligation to disclose the details of our decision to take such action with you.

10.2. <u>Limiting API Requests</u>. If applicable to a particular Service, we retain sole discretion to limit your usage of the Services (including without limitation by limiting the

number of API requests you may submit ("API Requests")) at any time if your usage of the Services exceeds the applicable threshold for your Selected Service.

10.3. <u>Reassignment of Identifiers</u>. You understand that we, in our sole discretion, may disable your access to the Service and/or reassign your username or other associated identifiers.

11. TERMINATION

11.1. *Termination*.

- (a) Terms of this Agreement. You agree to all terms in this Agreement if you use or access the Services.
- (b) *Termination for Convenience*. You may terminate this Agreement for any reason by ceasing use of the Services and disconnecting your wallet.
- (c) Termination for Cause. (i) By Either Party. Either party may terminate this Agreement for cause if the other party is in material breach of this Agreement and the material breach remains uncured for a period of 30 days from receipt of notice by the other party. (ii) By Us. We may also terminate this Agreement immediately upon notice to you at our sole discretion. We further reserve the right to change or modify these Terms of Use at any time and in our sole discretion.

11.2. <u>Effects of Termination</u>. Upon the Termination Date:

- (a) all your rights under this Agreement shall immediately terminate;
- (b) each party remains responsible for all fees and charges it has incurred through the Termination Date and are responsible for any fees and charges it incurs during the post-termination period; and
- (c) All sections which by their nature should survive the termination of this Agreement shall continue to apply in full force and effect subsequent to and notwithstanding any termination of these Terms by you or Sky Mavis. Termination will not limit any of our other rights or remedies at law or in equity.

Upon the termination of this Agreement and unless otherwise agreed between you and us in writing, you retain ownership of your respective Digital Collectibles and may access your Digital Collectibles through public blockchains and other digital wallet applications, platforms, and/or websites. Notwithstanding any such termination and for the avoidance of doubt, these Terms will continue to apply with respect to any Digital Collectible owned by you and all of your User Content.

WITHOUT LIMITING ANY OTHER PROVISION OF THESE TERMS OF USE, WE RESERVE THE RIGHT TO, IN OUR SOLE DISCRETION AND WITHOUT NOTICE OR LIABILITY, TERMINATE THIS AGREEMENT AND/OR DENY ACCESS TO AND USE OF THE SERVICES (INCLUDING BLOCKING CERTAIN IP ADDRESSES AND/OR BLOCKCHAIN ADDRESSES) TO ANY PERSON

FOR ANY REASON OR FOR NO REASON, INCLUDING WITHOUT LIMITATION FOR BREACH OF ANY REPRESENTATION, WARRANTY, OR COVENANT CONTAINED IN THESE TERMS OF USE OR FOR VIOLATION OF ANY APPLICABLE LAW, RULE, OR REGULATION. WE MAY TERMINATE YOUR USE OF OR PARTICIPATION IN THE SERVICES OR DELETE YOUR ACCOUNT WITHOUT WARNING, IN OUR SOLE DISCRETION.

11.3. <u>Termination or Suspension of Your Account</u>. If we terminate or suspend your access to the Services or to your Account for any reason, you are prohibited from registering and creating a new Account under your name, a fake or a borrowed name, or the name of any third party, or from otherwise using the Services, even if you are acting on behalf of the third party. In addition to terminating and suspending your Account, we reserve the right to take appropriate legal action, including without limitation, pursuing civil, criminal, and injunctive redress. You understand that any termination of your right to access and use the Services may involve deletion of your User Content associated with your use of the Services from our live databases. Sky Mavis will not have any liability whatsoever to you for any termination of your rights under these Terms, including for termination of your right to access and use the Services or deletion of your User Content. All sections intended by their nature to survive will survive the termination of this Agreement.

Digital Collectibles may not have intrinsic value, and their circulation may be limited and restricted.
- (c) Digital Collectibles are generally considered a high-risk asset class and may or may not be considered securities under certain jurisdictions. You must therefore exercise prudent judgment when trading Digital Collectibles.

- correct amount of taxes to the appropriate tax authorities. We are not responsible for determining, withholding, collecting, reporting, or remitting any taxes that apply to your Digital Collectibles or any sale or purchase of your Digital Collectibles.
- (I) You understand that there are risks associated with purchasing items associated with content created by third parties through peer-to-peer transactions, including but not limited to, the risk of purchasing counterfeit items, mislabeled items, items that are vulnerable to metadata decay, bugs in items on smart contracts, and items that become non-transferable. - (o) We do not have ownership or control of the smart contracts deployed by third parties, and we are not responsible and make no guarantees regarding their capabilities, operation, or functionality.
- (p) We do not control the public Blockchains that you are interacting with, and we do not control certain smart contracts that are integral to your ability to complete transactions on these public blockchains. Additionally, blockchain transactions are irreversible, and we have no ability to reverse any transactions on the blockchain.
- (q) We are not responsible for casualties due to developers' or representatives' delay or failure to report any issues with any Blockchain supporting Digital Collectibles, including without limitation, forks, technical node issues, or any other issues that result in losses of any sort.
- (r) There are risks associated with using Internet and blockchain-based products, including but not limited to, the risk associated with hardware, software, and Internet connections, malicious software introduction, and the risk that third parties may obtain unauthorized or misrepresented access to your third-party wallet or Account. - 13.1. <u>General</u>. If we become aware of any possible violations by you of these Terms of Use, we reserve the right to investigate such violations. If, as a result of the investigation, we believe that criminal activity may have occurred, we reserve the right to refer the matter to, and to cooperate with, any and all relevant authorities.
- 13.2. <u>Disclosures</u>. We are entitled, except to the extent prohibited by applicable law, to disclose any information or materials on or in the Services, including your User Content, in our possession in connection with your use of the Services, to: (i) comply with applicable laws, legal process, or governmental request; (ii) enforce these Terms of Use; (iii) respond to any claims that your Content violates the rights of third parties; (iv) respond to your requests for customer service; or (v) protect the rights, property, or personal safety of Sky Mavis, its users, or the public, and all law enforcement or other governmental officials, as Sky Mavis in its sole discretion believes to be necessary or appropriate. By agreeing to these Terms of Use, you hereby provide your irrevocable consent to such monitoring. You acknowledge and agree that you have no expectation of privacy concerning your use of the Services, including without limitation, text, voice, or video communications.

14. INDEMNIFICATION

14.1. General.

(a) You will defend, indemnify, and hold harmless all Sky Mavis Parties (as defined above) from and against any actual or alleged claims, damages, awards, Losses, liabilities, judgments, taxes, obligations, penalties, interest, fees, expenses, and costs of every kind and nature whatsoever concerning, caused by, arising out of, or related to: (i) a breach of this Agreement or violation of applicable law by you; (ii) any Submissions you provide; (iii) your use or misuse of the Services, content, Digital Collectibles, or content linked to or associated with any Digital Collectibles; (iv) your violation of the rights of or obligations to a third party, including another user or third party; and/or (v) your negligence or willful misconduct. You will reimburse us

- for reasonable attorneys' fees and expenses, associated with claims described in (i) through (v) above.
- (b) You understand and agree that you will promptly notify Sky Mavis of any potential claims and cooperate with Sky Mavis Parties in defending such claims. You further agree that Sky Mavis Parties shall have control of the defense or settlement of any claims. THIS INDEMNIFICATION IS IN ADDITION TO AND NOT IN LIEU OF ANY OTHER INDEMNIFICATION SET FORTH IN A WRITTEN AGREEMENT BETWEEN YOU AND SKY MAVIS.

14.2. <u>Intellectual Property</u>.

- (a) Subject to the limitations in this Section 14, you will defend Sky Mavis Parties against any third-party claim alleging that any of Your Content infringes or misappropriates that third party's intellectual property rights, and you will pay the amount of any adverse final judgment or settlement.
- (b) Furthermore, Sky Mavis Parties will have no obligations or liability under this Section 14.2 arising from infringement by your combinations of the Services with any other product, service, software, data, content or method. In addition, we will have no obligations or liability arising from your use of the Services after we have notified you to discontinue such use. The remedies provided in this Section 14.2 are the sole and exclusive remedies for any third-party claims of infringement or misappropriation of intellectual property rights by the Services or by Your Content.
- (c) In no event can you agree to any settlement of any claim that involves any commitment, other than the payment of money, without our written consent.

15. LIMITATION OF LIABILITY

15.1. <u>Limitation of Liability</u>. To the fullest extent permitted by Law, In No event Will sky Mavis, Its affiliates, or its service providers have any liability to you or any third party for: (a) any indirect, special, incidental, consequential, cover, business interruption or punitive damages arising from these terms or the services, products, or third-party sites, platforms, and products, including without limitation, any loss of profits (whether incurred directly or indirectly), loss of goodwill or business reputation, loss of data, cost of procurement of substitute goods or services, loss of use, loss of business or anticipated savings, or any other intangible loss, even if you have been advised of the possibility of such damages, if the damages or their possibility are foreseeable, whether an action is in contract or tort and regardless of the theory of liability; (b) any other claim, damages, or demand whatsoever resulting from or arising from or in connection with these terms for the use, performance, or delivery of the services.

- 15.2. <u>Use of Services is at Your Own Risk</u>. YOU UNDERSTAND THAT ACCESS TO, AND USE OF THE SERVICES, PRODUCTS, OR THIRD-PARTY SITES AND PLATFORMS, ARE AT YOUR OWN RISK AND AT YOUR OWN DISCRETION, AND YOU ARE SOLELY RESPONSIBLE FOR ANY DAMAGES TO YOUR COMPUTER SYSTEM OR MOBILE DEVICE OR ANY OTHER HARDWARE OR SOFTWARE YOU USE TO ACCESS OR USE OUR SERVICES, OR THE LOSS OF DATA RESULTING THEREFROM.
- 15.3. <u>Maximum Aggregate Liability</u>. NOTWITHSTANDING ANYTHING TO THE CONTRARY CONTAINED HEREIN, IN NO EVENT SHALL THE MAXIMUM AGGREGATE LIABILITY OF SKY MAVIS ARISING OUT OF OR IN ANY WAY RELATED TO THESE TERMS, THE USE OF AND ACCESS TO OUR SERVICES, CONTENT, DIGITAL COLLECTIBLES, OR ANY OTHER PRODUCTS OR SERVICES EXCEED THE GREATER OF (A) \$100 OR (B) THE AMOUNT RECEIVED BY SKY MAVIS FOR ITS SERVICES TO YOU DIRECTLY RELATING TO THE ITEMS THAT ARE THE SUBJECT OF THE CLAIM. THE FOREGOING LIMITATIONS WILL APPLY EVEN IF THE ABOVE STATED REMEDY FAILS OF ITS ESSENTIAL PURPOSE.
- 15.4. <u>Jurisdictional Limitations</u>. You understand and accept that some jurisdictions do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. Some jurisdictions may also limit disclaimers or limitations of liability for personal injury from consumer products, so this limitation may not apply to personal injury claims.

16. GOVERNING LAW AND VENUE

16.1. <u>General</u>. These Terms of Use, your use of the Services, and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with it or its subject matter or formation shall be governed by and construed in accordance with the laws of Singapore without regard to principles of conflicts of law.

17. BINDING ARBITRATION AND CLASS ACTION WAIVER

PLEASE READ THIS SECTION CAREFULLY – IT MAY SIGNIFICANTLY AFFECT YOUR LEGAL RIGHTS, INCLUDING YOUR RIGHT TO FILE A LAWSUIT IN COURT.

17.1. <u>Binding Arbitration</u>. Unless otherwise required by applicable law, any dispute, claim or controversy ("**Claim**") relating in any way to this Agreement, the Ronin Market, or your use of the Services will be finally resolved by binding arbitration as provided in this Section 17, rather than in court.

The arbitration shall be administered by the Singapore International Arbitration Centre ("SIAC") in accordance with the SIAC Rules in force at the time the Claim is submitted, which rules are deemed incorporated by reference in this Section. The seat of arbitration shall be Singapore. The tribunal shall consist of one (1) arbitrator to be appointed in

accordance with the SIAC Rules for the time being in force, and the language of the arbitration shall be in English.

17.2. <u>Class Action Waiver</u>. YOU AND WE AGREE THAT EACH MAY BRING CLAIMS AGAINST THE OTHER ONLY ON AN INDIVIDUAL BASIS, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS OR REPRESENTATIVE PROCEEDING. YOU AND WE EXPRESSLY WAIVE ANY RIGHT TO FILE A CLASS ACTION OR SEEK RELIEF ON A CLASS BASIS.

Unless both you and we agree, no arbitrator or judge may consolidate more than one person's claims or otherwise preside over any form of a representative or class proceeding. The arbitrator may award injunctive relief only in favor of the individual party seeking relief and only to the extent necessary to provide relief warranted by that party's individual claim. If a court decides that applicable law precludes enforcement of any of this paragraph's limitations as to a particular claim for relief, then that claim (and only that claim) must be severed from the arbitration and may be brought in court. If any court or arbitrator determines that the class action waiver set forth in this paragraph is void or unenforceable for any reason or that an arbitration can proceed on a class basis, then the arbitration provision set forth above shall be deemed null and void in its entirety and the parties shall be deemed to have not agreed to arbitrate disputes.

- 17.3. <u>30-Day Right to Opt Out</u>. You have the right to opt-out and not be bound by the arbitration and class action waiver provisions set forth above by sending written notice of your decision to opt-out to the following address: via email at notices@skymavis.com with the subject line "LEGAL OPT OUT." The notice must be sent within 30 days of you first using our Services under this Agreement, otherwise, you shall be bound to arbitrate disputes in accordance with the terms of those paragraphs. If you opt-out of these arbitration provisions, we will also not be bound by them.
- 17.4. <u>Exceptions to Arbitration</u>. Sky Mavis and you each agree that the following Claims are not subject to the above provision concerning binding arbitration: (a) any Claim seeking to enforce or protect, or concerning the validity of, the intellectual property rights of a Party; (b) any Claim related to, or arising from, allegations of theft, piracy, invasion of privacy, or unauthorized use; and (c) any claim for injunctive relief. Sky Mavis and you each agree that, if any portion of this provision is found to be unenforceable, then neither party will elect to arbitrate any Claim falling within that portion of this provision found to be unenforceable, and such Claim shall be decided by a court of competent jurisdiction located in Singapore, sitting in Singapore.

18. MISCELLANEOUS

18.1. <u>Assignment</u>. You will not assign or otherwise transfer this Agreement or any of your rights and obligations under this Agreement, without our prior written consent. Any assignment or transfer in violation of this Section 18.1 will be void. We may assign

this Agreement without your consent (a) in connection with a merger, acquisition or sale of all or substantially all of our assets, or (b) to any Affiliate or as part of a corporate reorganization; and effective upon such assignment, the assignee is deemed substituted for us as a party to this Agreement and we are fully released from all of our obligations and duties to perform under this Agreement. Subject to the foregoing, this Agreement will be binding upon, and inure to the benefit of the parties and their respective permitted successors and assigns.

- 18.2. <u>Entire Agreement and Modifications</u>. This Agreement incorporates the Policies by reference and is the entire agreement between you and us regarding the subject matter of this Agreement. If the terms of this document are inconsistent with the terms contained in any Policy, the terms contained in this document will control. Any modification to the terms of this Agreement may only be made in writing.
- 18.3. <u>Force Majeure</u>. Neither party nor their respective Affiliates will be liable for any delay or failure to perform any obligation under this Agreement where the delay or failure results from any cause beyond such party's reasonable control, including but not limited to acts of God, utilities or other telecommunications failures, cyber-attacks, earthquake, storms or other elements of nature, pandemics, blockages, embargoes, riots, acts or orders of government, acts of terrorism, or war.
- 18.4. Export and Sanctions Compliance. Sky Mavis represents and warrants that (i) it is duly incorporated and in good standing under the laws of the jurisdiction in which it is incorporated, (ii) it has all necessary rights, power, legal capacity, and authority to enter into and fully perform the terms of this Agreement, (iii) it is not domiciled in or a resident of, physically present or located in, or has business activities in jurisdictions in which the Services are prohibited, restricted or unauthorized in any form or manner whether in full or in part under the laws, regulatory requirements or rules in such jurisdiction; (iv) it is not domiciled in or a resident of, physically present or located in, or conducts business activities in or with counterparties located in jurisdictions that are identified by the Monetary Authority of Singapore as subject to economic or trade sanctions under regulations promulgated under the Monetary Authority of Singapore Act (Chapter 186) of Singapore, the United Nations Act (Chapter 339) of Singapore, the Terrorism (Suppression of Financing) Act (Chapter 325) of Singapore, or the Office of Financial Assets Control of the United States Department of the Treasury (collectively, the "Economic Sanctions Laws"); (v) it is in compliance with Economic Sanctions Laws.
- 18.5. <u>Independent Contractors; Non-Exclusive Rights</u>. We and you are independent contractors, and this Agreement will not be construed to create a partnership, joint venture, agency, or employment relationship. Neither party, nor any of their respective Affiliates, is an agent of the other for any purpose or has the authority to bind the other. Both parties reserve the right (a) to develop or have developed for its products, services, concepts, systems, or techniques that are similar to or compete with the products, services, concepts, systems, or techniques developed or contemplated by the other

party, and (b) to assist third party developers or systems integrators who may offer products or services which compete with the other party's products or services.

- 18.6. <u>Eligibility.</u> If you are under the age of majority in your jurisdiction of residence, you may not use the Ronin Market or Services.
- 18.7. <u>Language</u>. All communications and notices made or given pursuant to this Agreement must be in the English language. If we provide a translation of the English language version of this Agreement, the English language version of the Agreement will control if there is any conflict.

18.8. *Notice*.

- (a) To You. We may provide any notice to you under this Agreement by: (i) posting a notice on the Ronin Market; or (ii) sending a message to the email address then associated with your Account. Notices we provide by posting on the Ronin Market will be effective upon posting and notices we provide by email will be effective when we send the email. It is your responsibility to keep your email address current. You will be deemed to have received any email sent to the email address then associated with your account when we send the email, whether you actually receive the email.
- (b) To Us. To give us notice under this Agreement, you must contact us by email at notices@skymavis.com.
- 18.9. <u>No Third-Party Beneficiaries</u>. Except as otherwise set forth herein, this Agreement does not create any third-party beneficiary rights in any individual or entity that is not a party to this Agreement.
- 18.10. <u>No Waivers</u>. The failure by us to enforce any provision of this Agreement will not constitute a present or future waiver of such provision nor limit our right to enforce such provision at a later time. All waivers by us must be in writing to be effective.
- 18.11. <u>Severability.</u> If any portion of this Agreement is held to be invalid or unenforceable, the remaining portions of this Agreement will remain in full force and effect. Any invalid or unenforceable portions will be interpreted to effect and intent of the original portion. If such construction is not possible, the invalid or unenforceable portion will be severed from this Agreement, but the rest of the Agreement will remain in full force and effect.

19. Definitions

"Account Information" means information about you that you provide to us in connection with the creation or administration of your Account. For example, Account Information may include names, usernames, phone numbers, email addresses and billing information associated with your Account.

"API" means an application program interface.

"API Request" has the meaning set forth in Section 10.2.

"Content" means software (including machine images), data, text, audio, video or images and any documentation we offer for the Services as well as the general "look and feel" of Sky Mavis' services and products, including the Ronin Market, proprietary content, information and other materials, and all content and other materials contained herein, including without limitation, Our Marks as defined below, data, software, sound files, other files, and the selection and arrangement thereof.

"Digital Collectible" means a non-fungible token or similar digital item implemented on a Blockchain (such as the Ronin blockchain or any other blockchain), which uses smart contracts to link to or is otherwise associated with particular content or data, including the colloquial term of "NFTs".

"End User" means any individual or entity that directly or indirectly through another user: (a) accesses or uses Your Content; or (b) otherwise accesses or uses the Service Offerings under your account.

"Losses" means any claims, damages, losses, liabilities, costs, and expenses (including reasonable attorneys' fees).

"Our Marks" means any trademarks, service marks, service or trade names, logos, and other designations of Sky Mavis Pte. Ltd. and their affiliates or licensors that we may make available to you in connection with these Terms of Use.

"**Policies**" means this Agreement, the Acceptable Use Policy, Privacy Policy, any supplemental policies or addendums applicable to any Service as provided to you, and any other policy or terms referenced in or incorporated into this Agreement, each as may be updated by us from time to time.

"Service" means any of the services relating to or arising from Ronin Market or any other related features, tools, materials, or services offered from time to time by us or our affiliates.

"Service Offerings" means the Services (including any associated APIs as applicable), Our Content, Our Marks, and any other product or service provided by us under this Agreement. Service Offerings do not include Third-Party Content or Third-Party Services.

"Suggestions" means all suggested improvements to the Service Offerings that you provide to us.

"Term" means the term of this Agreement described in Section 11.1.

"**Termination Date**" means the effective date of termination provided in accordance with Section 11.

"Third-Party Content" means Content made available to you by any third party on the Ronin Market or in conjunction with the Services.

"Third-Party Websites" mean any third-party websites made available to you on the Ronin Market or in conjunction with the Services.

"User Content" means any information and content that a user provides, submits to, or uses with, the Services (e.g., content in the user's profile or postings) or any of Sky Mavis' profiles on other properties (e.g., Discord).

"Your Content" means Content that you or any End User transfers to us for processing, storage or hosting by the Services in connection with Account and any computational results that you or any End User derive from the foregoing through their use of the Services. Your Content does not include Account Information.
